I understand that I must show respect for the facilities and equipment of Tates Creek Christian Church. I will show respect to and follow instructions given by church staff. I will participate in cleanup of the building and will clean up after myself.

I will refrain from any illegal, immoral, or unhealthy activity while at New Horizons Academy. Conduct both in and out of class may be considered in determining continued participation in the program.

I understand that violations of this Code of Conduct or other rules set out by teachers or other adults in charge may result in:

- Dismissal for the remainder of the semester (with no refund of fees)
- Permanent dismissal
- Being required to pay the costs of any repairs necessary due to damage to property
- Being required to apologize in person and/or in writing for violations

I will supervise the completion of all academic assignments and will insure cooperation with any of the above consequences which could result from violations of the Code of Conduct.
